



# 2012 NC Cooperative Extension Perquimans County Report

### 33 families participated in EFNEP

- 24% of EFNEP participants were also WIC participants.
- 82% of EFNEP participants enrolled in one or more food assistance programs.

### EFNEP Makes a Real Difference for Limited Resource Adults

- 79% improved in one or more food safety practices
- 90% improved in one or more nutrition practices
- improved in one or more food resource management practices
- 50% of participants increased the amount of daily physical activity
- 100% of participants improved their diet
- 63% drank fewer sugar-sweetened beverages
- increased number of weekly meals eaten together as a family

### EFNEP Makes a Real Difference for 480 Limited Resource Youth

- 68% increased variety of foods in their diet
- 78% increased their knowledge of human nutrition
- 88% increased their ability to select low-cost, nutritious foods
- 25% improved practices in food preparation and safety



### What Is EFNEP?

EFNEP serves limited-resource families with young children, school-age youth, and pregnant teens through a series of lessons offered by paraprofessionals and volunteers, many of whom are indigenous to the population.

Using "hands-on" experiences, participants are taught to: make wise choices with their food dollars, improve eating habits, and practice food safety principles.

EFNEP is offered through North Carolina Cooperative Extension as a part of university outreach at NC State University and NC A&T State University. In 2012, North Carolina EFNEP served 57 counties.

## **Chronic Disease in North Carolina: A Growing Problem**

When compared to other states, North Carolina ranks poorly in health. In 2009, *North Carolina stood 37th among the 50 states for overall health*. The state ranks low in many health indicators, including obesity prevalence (41st), premature death (40th), and cancer death rates (35th). *Fewer adults in North Carolina are physically active and more are obese* when compared to national averages.<sup>2</sup>

Especially concerning is that low income, non-white populations are disproportionally affected by these indicators. In North Carolina, 42.4% of non-Hispanic blacks are obese, compared to 26.7% of non-Hispanic whites. In addition, 15.3% of non-Hispanic blacks have diabetes, compared to 8.4% of non-Hispanic whites and 4.9% of Hispanics.<sup>3</sup>
