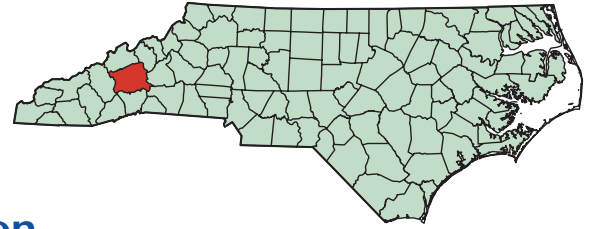

## 2013 NC Cooperative Extension Buncombe County Report

### 156 families participated in EFNEP

- 19% of EFNEP participants were also WIC participants.
- 59% of EFNEP participants enrolled in one or more food assistance programs.

### EFNEP Makes a Real Difference for Limited Resource Adults

- 82% improved in one or more food safety practices
- 83% improved in one or more nutrition practices
- 91% improved in one or more food resource management practices
- 47% of participants increased the amount of daily physical activity
- 100% of participants improved their diet
  - 80% increased fruit consumption
  - 66% increased vegetable consumption
  - 76% increased consumption of calcium-rich foods

### EFNEP Makes a Real Difference for 1368 Limited Resource Youth

Participants who showed improvement in one or more core areas:

- 100% of children in grades K-2
- 100% of children, grades 3-5



### What Is EFNEP?

EFNEP serves limited-resource families with young children, school-age youth, and pregnant teens through a series of lessons offered by paraprofessionals and volunteers, many of whom are indigenous to the population.

Using “hands-on” experiences, participants are taught to: make wise choices with their food dollars, improve eating habits, and practice food safety principles.

EFNEP is offered through North Carolina Cooperative Extension as a part of university outreach at NC State University and NC A&T State University. In 2013, North Carolina EFNEP served 50 counties.

### Food Insecurity, Chronic Disease and Economic Implications for North Carolina

Food insecurity and chronic disease affect both the health of our population and our economy. Children living in food insecure households are at greater risk of developmental and academic problems as well as nutritional deficiencies and nutrition-related illnesses. Addressing this issue in North Carolina is essential to the preparation of our future workforce and economic growth in our state. The challenges are great.

Between 2008 and 2012, North Carolina saw a rise from 22% to 24% in the number of working low-income families with children. This 2% increase accounts for 27,000 additional families with children earning incomes at or below the poverty level. During the same time frame, the number of children living in poverty in North Carolina increased from 20% to 26%.<sup>1</sup>

When compared to other states, North Carolina ranks poorly in health. 29.6% of adults in North Carolina are obese. What is even more alarming is that 15.4% of 2-4-year olds living in North Carolina are obese, making our children the 7th most obese in the nation. Additionally, North Carolina has the 18th highest rate of diabetes and the 17th highest rate of hypertension.<sup>2</sup>
